#### **COURSING ABILITY TEST**

Open to all AKC registered dog breeds, dogs with ILP/PAL registration #s, and All-American dogs listed in the Canine Partners Program. <u>Dogs</u> must be at least 12 mo of age.

300 yard Course: This distance is for dogs shorter than 12" at the withers or brachycephalic (flat-faced) dogs. A dog must complete this course in less than 1 ½ minutes.

Vets (dogs 7 yrs and older) may run this course.

**600 yard Course:** This distance is used for all dogs that do not run the 300 yrd course. A dog must complete this course in less than 2 minutes.

RIBBONS All passing runs will receive an orange qualifying ribbon.

#### GENERAL INFORMATION

- 1. Dogs not present at the time of roll call will be scratched after a 5-minute grace period.
- 2. Bitches in season and lame dogs will be excused and have their entry fees refunded.
- 3. Spayed and neutered dogs may be entered.
- 4. Gas-powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.
- 5. A \$5 fine will be assessed for loose dogs during courses in progress.
- 6. A \$20 fine will be assessed for failing to clean up their dogs' waste.
- 7. Please bring your own food, shade, ink pen, and water.
- 8. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
- 9. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- 10. AHGA assumes no liability for injury to any person or dog before, during or after the Tests.
- 11. AHGA cannot predict the time needed to complete this event and it may last for the duration of daylight hours.
- 12. A port-a-potty with hand washing station will be on site.
- 13. Park with sufficient space between vehicles.
- 14. Provide day-of cell phone contact on your entry form.


