# **Rolling Roll Call**

The hope is that rolling roll call reduces the amount of time people are waiting during our events and that people who have multiple dog events happening on the same day can still do both events. This is the first time our club has done this, so please be patient and we work through figuring out what works/doesn't work! Please still come help with set-up and clean-up!

There are two Fast CAT Trials taking place at this event. This event will be a **ROLLING ROLL CALL** event. This means you may arrive anytime between 9:30am and 2:30pm.

When you arrive, you will get in line for inspections at the secretary's tent. Each dog will be inspected by the Inspection Committee for lameness, fitness to compete, and females in season per the AKC rules and regulations. All dogs to be inspected must be presented without tape, bandages, or wrapping/coverings of any kind (coats, blankets, etc.). If, in the opinion of the Inspection Committee, a dog is found to be lame, unfit to compete, or in season, the dog will not be allowed to test, and the applicable entry fees will be refunded.

After your dog(s) have been inspected, you are able to get in line at the release end of the shoot with your dog. There will be no run order posted, run order will be based on whoever is first in line. Have a catcher ready at the end of the shoot! If you do not have a catcher ready at the other end, the next person in line that is ready will run.

Once your dog runs once, your dog must get reinspected before they can run again. Bring your dog back to the secretary's tent to get reinspected and checked off the list. The only rule is there must be 15 minutes between your dog's first and second runs, but you may essentially run 1 dog back-to-back. If you feel your dog(s) need a longer break, just wait longer until you get back in line at the release end with them.

# **How Entries Work**

Entries will be recorded in the order in which they are received.

Please print and fill out, or digitally fill out, the form found at the end of *this* Premium. Please ensure your dog's registered name and registration number are written correctly and legibly.

Please ensure your email address is written legibly. Email confirmation will be sent out once the entry has been received (expect to receive confirmation withing 48 hours of entry being received). Please check your spam folder prior to reaching out!

After the entry has been received, instructions for paying via PayPal will be sent with the confirmation email. Please do not pay on PayPal until you receive the confirmation email. After the confirmation email has been sent, payment must be received within 48 hours to secure your spot. Please forward your email from PayPal showing proof of payment to the trial secretary to confirm payment (Alaska.Hound.Secretary@gmail.com). If payment is not received within 48 hours, you will be shifted to the end of the received entries list. You will still have a spot if the trial is not full before payment is received.

If paying cash or check, you may add it to the mailed in entries. If trial limits have been met, the owner will be notified, and the check will be shredded, and cash may be transferred to a future run or returned.

Updates will be sporadically posted to our Facebook page about the number of entries received and number of remaining spots. #### **FAST CATS**

Open to all AKC registered dog breeds, dogs with ILP/PAL registration numbers, and All-American dogs listed in the Canine Partners Program. Dogs must be at least 12 months of age to participate.

#### **TIMES AND POINTS**

The dogs run, singularly, a 100-yard straight dash. The time to complete this run is converted into miles per hour (mph). Points are earned based on the handicapped speed and titles are awarded when the dog has accumulated a given number of points.

A standard formula is used to convert time and handicap into mph.

$$\frac{204.545}{\text{Dog's time}} = \mathbf{MPH}$$

 $MPH \times HANICAP = POINTS$ 

Your dog's handicap is based on their height at their withers:

\*\*18" or greater = handicap 1.0

\*\*12" up to 17.9" = handicap 1.5

\*\*Under 12" = handicap 2.0

Titles are earned by accumulating points.

BCAT = 150 pts

FCAT = 1000 pts

DCAT = 500 pts

FCAT# = every additional 500 points

#### **RIBBONS**

Light blue participation ribbons will be awarded to all dogs passing their tests, new title ribbons are available as your dog earns new titles, find the trial secretary table to collect your ribbons!

Rabbit Award: Fastest time in each of the height classes.

<u>Turtle Award</u>: Slowest time in each of the height classes

<u>Jackrabbit Award</u>: Fastest time in each height class over the course of the season <u>Sloth Award</u>: Slowest time in each height class over the course of the season

#### **REMINDERS:**

- \*\* Check the run order day of and be standing by when your run is near
- \*\* Make sure you have a releaser, and a catcher arranged for your dog(s)
- \*\* Have a collar and leash available for both the catcher and releaser
- \*\* No running down the middle of the shoot
- \*\* No treats, toys or mechanical whistles can be used in the shoot
- \*\* Try to catch the dog as quickly as possible and leave the catch-area so the next run may commence
- \*\* Listen to the Paddock master and Huntmaster

#### **GENERAL INFORMATION**

- 1. Dogs not present at the time of roll call will be scratched after a 10-minute grace period.
- 2. Bitches in season and lame dogs will be excused and have their entry fees refunded.
- 3. Spayed and neutered dogs may be entered.
- 4. Gas powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.
- 5. A \$5 fine will be assessed for loose dogs during courses in progress.
- 6. A \$20 fine will be assessed for failing to clean up their dogs' waste.
- 7. Please bring your own food, pen, shade and water if required.
- 8. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
- 9. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- 10. AHGA assumes no liability for injury to any person or dog before, during or after the Tests.
- 11. AHGA cannot predict the time needed to complete this event and it may last for the duration of daylight hours.
- 12. Park with sufficient space between vehicles.
- 13. Provide day-of cell phone contact on your entry form.
- 14. Please fill out the entry form legibly and make sure your email is correct.
- 15.Dogs should be on a leash at all times, except while running the dash.
- 16. A port-a-potty will be on site, as well as a hand washing station.
- 17. Dogs are to run with a flat collar or nothing. Harnesses, martingales and muzzles are allowed. Tags must be tied to the collar and not dangling. No, choke, prong or e-collars. Note: any collar can add risk to the running dog should it catch on something.
- 18. Results will be posted to the webpage after the event. www.akhoundgroup.wix.com/ahga
- 19. Timer is an electronic break-the-beam timing system. Manual timers will be used as a backup.
- 20. Within a Block, dogs that have not yet run their first will have priority over dogs that will be running their second test.
- 21. Dogs that pee/poop/puke within the chute will be given a "No Time," and excused.
- 22. Report aggressive dogs and/or owners and any unsportsmanlike conduct to the Field Chairman or Trial Secretary, preferably as soon as it happens. Do not wait until the end of the event or on another day!
